

RULES OF THE 2021 CALL FOR GRANTS FOR INITIATIVES PROPOSED BY MEMBERS

- 1. The initiatives proposed must comply with the objectives of our association, established in article 4 of the statutes, which defines as the main objective the promotion of urban regeneration and sustainable rehabilitation.
- 2. According to the mentioned objectives, we could distinguish different proposals modalities:
 - a. International cooperation initiatives in the field of urban regeneration and building rehabilitation.
 - b. Local and national cooperation initiatives in the field of urban regeneration and building rehabilitation.
 - c. Research projects in the field of urban regeneration and the rehabilitation of buildings, preferably related to formal university structures.
 - d. Training activities to improve skills in urban regeneration and building rehabilitation and in the dissemination of the RehabiMed method.
 - e. Awareness-raising activities regarding the importance of safeguarding architectural heritage as a factor in sustainable development.
 - f. To promote dialogue between cultures, generations and genres, by preserving the historical and cultural identity of architectural heritage.
 - g. Provide technical support to NGOs and local authorities in their activities related to urban regeneration and the rehabilitation of buildings.
 - h. Other types of actions aimed at the goals of RehabiMed.

3. Scope of action.

The proposals raised can be developed at the local, national and international levels, always from a development cooperation perspective. The Mediterranean area is a priority, but this does not exclude any place in the world.

4. Requirements for aid recipients.

Be a member of the association. Only one initiative per call and associate can be funded.

5. Execution period.

Grant activities must be carried out within 2 years of the approval of the grant and in accordance with the timetable proposed by the applicant.

6. Formalization of applications.

Applications must be submitted using the form available online at https://forms.gle/g5cTJZxcsjMggfr77, before the deadline set for the call.

7. Content of applications

- a. Title of the initiative.
- b. Project manager. Participants in the project, RehabiMed's members and from external entities.
- c. Brief description of the project. Objectives, development and expected results.
- d. Place of development.
- e. Schedule.
- f. Total budget, amount requested and % of co-financing external to the association.

8. Resolution of the call



The call will be resolved 60 days after its closing and the results will be published on the website of the Association. Five-members of RehabiMed Board will evaluate the proposals.

9. Monitoring and justification of activities.

A member of the RehabiMed Board will be appointed responsible for monitoring each project and interlocutor with the beneficiary. With him/her you will:

- a. Report on the real deadlines for carrying out the activities. Original or adjusted schedule of the activity.
- b. Report all types of contingencies, delays, etc. and justify them.
- c. Job follow-up reports (if applicable)
- d. The final results report must be submitted within two months of the closure of the planned activities.
- e. The final results report will include the financial report and proof of expenses will be attached.

10. Payment of aid.

The amount of aid awarded will be paid in two fases, 50% upon signing the award agreement and the remainder once the final report and financial report have been submitted. Where required, the second 50% may be paid in part by completing and justifying steps set out in the proposal.

11. Dissemination of activities.

The beneficiary of the aid, undertakes to disseminate the activities carried out and has stated the contribution of RehabiMed in them.

12. Revocation of aid.

If the proposed activity is not carried out, or if the initial proposal is not respected without the prior acceptance of RehabiMed, the amount already paid will be reimbursed within 30 days of meeting the established deadlines.

13. Participation.

Participation in this Call means acceptance of these Rules and the decision of the Commission created for this purpose, which will be final.

14. Funding of the Call

The Call for Grants for 2021 is endowed with € 10,000, from the association's own funds.
